THE ORDER OF THE GINGKO BY-LAWS

PREAMBLE:

Yet even now in the miasma of modern industrial society, there has been revealed to a select few the secret of this spiritual kinship. Rejoice therefore all ye lands! No longer shall the Gingko be as a tree among trees, but as a brother among brethren. To this end the Order of the Gingko has dedicated and will dedicate itself.

Our principles are high; our motivations holy. To bud, to grow, to spread shining bilobed fans of green among bent and twining boughs that sieve the fingers of the wind, to lace the soil with curious roots, ay!, even to you, o Gingko, shall we aspire!

Article I - Membership

- SECTION 1. An affirmative vote of 100% by the Four Tops shall be necessary to enter into membership in this society.
- SECTION 2. A negative vote of 100% by the Four Tops shall be necessary to expel a member from this society.
- SECTION 3. Honorary membership in this noble society may be conferred by the unanimous vote of the Four Tops.
- SECTION 4. The advisor shall be a faculty member, preferably engaged in the study of one of the natural sciences.
- SECTION 5. A permanent record of the active, advisory, honorary,, and alumni members of this society shall be kept on record in the archives of this society by the Keeper of the Papyrus Root.

Article II - Titles

SECTION 1. The titles for the members of this society shall be:
Omniscient Omnipotent Grandest Supreme Mulch, Extreme Exalted High
Mulch Excelsior, Extra Extreme Grandest Mulch Excelsior, Superior
Extreme Grandest High Mulch, Grand Imperial Chainsaw Interceptor,
Extreme Grandest Under Mulch, Keeper of the Rake, Keeper of the

Compost, Keeper of the Papyrus Root, Extreme Under Mulch, Grand Imperial Bushy-Tailed Ground Squirrel, Pips, and Squirrels.

SECTION 2. The Four Tops shall bestow titles upon the members at the first of each semester.

SECTION 3. Graduating Four Tops shall bestow their title to an understudy within 24 hours after their graduation.

Article III - Four Tops

SECTION 1. The Four Tops of this society will consist of the Omniscient Omnipotent Grandest Supreme Mulch, Extreme Exalted High Mulch Excelsior, Extra Extreme Grandest Mulch Excelsior, and the Superior Extreme Grandest High Mulch.

SECTION 2. The Four Tops will meet whenever they feel like it.

SECTION 3. Duties of the Four Tops:

- Clause 1. The Four Tops will exercise all the powers and deviant behaviors of this society during intervals between irregular society meetings.
- Clause 2. The Four Tops are responsible for carrying out the resolutions, proclamations, policies, decrees, activities, and absurdities of this society.
- Clause 3. The Four Tops will analyze the past projects of this society, weigh their value, and determine the advisability of their continuance or discontinuance.
- Clause 4. The Four Tops will sove all personal problems of this society by saying either yes or no. The word "maybe" does not count.

Article IV - Duties of Officers

SECTION 1. Omniscient Omnipotent Grandest Supreme Mulch. The OOGSM shall be a Four Top. He shall be everywhere and shall use his almighty power to preserve this society and the sacred Gingko Tree. He shall perform such other duties as his title may requird, but shall not wear alligators on his person.

SECTION 2. Extreme Exalted High Mulch Excelsior. The EEHME shall be a Four Top. He shall embark on all missions necessary to preserve this society and the Gingko Tree. He shall perform such duties as his title may require in addition to washing the Gingko Tree on Sunday afternoons.

SECTION 3. Extra Extreme Grandest Mulch Excelsior. The EEGME shall be a Four Top. He shall seek to eradicate all woodpeckers that touch the Gingko Tree. He shall perform such duties as his title probably may not require and shall insure that there is enough toilet paper in the Four Top's bathroom.

SECTION 4. Superior Extreme Grandest High Mulch. The SEGHM shall be a Four Top. He shall know all knowledge that is knowable about the Gingko Tree. He shall perform duties and is the only Four Top permitted to check out books form the library of the Gingko Tree.

SECTION 5. Grand Imperial Chainsaw Interceptor. The GICI shall attempt to abolish the Homelite Chainsas Company. He shall use his speed and dexterity to intercept all chainsaws that are approaching the Gingko Tree.

SECTION 6. Keeper of the Rake. The KOR shall keep the horrendous mulch machines away from the Gingko Tree. He shall keep a supply of tools in his closet and carry a rake on his person at all times.

SECTION 7. Keeper of the Compost. The KOC shall provide all nutrition for the Gingko Tree. He shall collect all materials necessary for feeding.

SECTION 8. Extreme Grandest Under Mulch. The EGUM shall communicate with the Gingko Tree Hoot Owl. He shall present all messages from the birk to the Four Tops after changing his clothers, having stood under the Hoot Owl for an hour or more.

SECTION 9. Extreme Grand Mulch. The EGM shall direct all UNC lady bugs to destroy all pests that infest the Gingko Tree. He shall clean up the carnage with Handi Wipes.

- SECTION 2. Duties of the Little Squirrels.
 - Clause 1. The Little Squirrels are responsible for carrying out the social events of this society.

Article VII - Society Committees

Clause 2. Special Projects Committee
